Arizona Professional School Counselor Job Description

Position: School Counselor

Leadership, advocacy, and collaboration are the skills school counselors will draw on to implement a preventative, proactive school counseling program using the *American School Counselor Association (ASCA) National Model: A Framework for School Counseling Programs* (2005). Counselors will promote student success through the implementation of this comprehensive school counseling program that addresses the academic, career, and personal/social needs of students.

Duties and Responsibilities:

- I. Major Function: <u>Development and Management</u> of a comprehensive school counseling program based on the ASCA National Model: A Framework for School Counseling Programs (2005).
 - **Standard 1:** The professional school counselor plans, organizes, and delivers the comprehensive school counseling program.
- II. Major Function: <u>Implementation</u> of a comprehensive school counseling program based on the ASCA National Model: A Framework for School Counseling Programs (2005).
 - **Standard 2:** The professional school counselor delivers and implements the guidance curriculum through the use of effective instructional skills and careful planning of structured classroom lessons and small group sessions.
 - **Standard 3:** The professional school counselor implements the individual student planning component by guiding individuals and groups of students and their parents through the development of education and career plans.
 - **Standard 4:** The professional school counselor implements the responsive services component through the effective use of individual and small group counseling, consultation and referral skills.
 - **Standard 5:** The professional school counselor implements the systems support component through effective guidance program management and support for other educational programs.

- III. Major function: <u>Accountability</u> of a comprehensive school counseling program based on the ASCA National Model: A Framework for School Counseling Programs (2005).
 - **Standard 6:** The professional school counselor meets with the school administrator at the beginning of the school year to discuss the counseling department management system and the program action plans using a yearly counselor/principal agreement.
 - **Standard 7:** The professional school counselor knows how to use data as a guide when deciding school counseling program direction and emphasis.
 - **Standard 8:** The professional school counselor monitors the students on a regular basis as they progress in school.
 - **Standard 9:** The professional school counselor implements the master calendar/time component to have an efficiently run program.
 - **Standard 10:** The professional school counselor has developed a results evaluation for the program.
 - **Standard 11:** The professional school counselor conducts yearly school counseling program audit.
 - **Standard 12:** The professional school counselor shares the results of the school counseling program with the advisory council.
- IV. Major Function: <u>Systems change agent</u> of a comprehensive school counseling program based on the *ASCA National Model: A Framework for School Counseling Programs (2005).*
 - **Standard 13**: The professional school counselor uses the skills of leadership, advocacy and collaboration to create systemic change to improve the academic and career success of all students.

Other information:

Counselors will continuously make data-driven decisions regarding the implementation of an ASCA model school counseling program.

- The American School Counselor Association recommends a ratio of 1 counselor for 250 students.
- Counselors will meet monthly by levels to continue work on their ASCA model school counseling program.
- Counselors will meet each quarter to share their progress on the implementation of the ASCA model school counseling program.

- Masters Degree in School Guidance and Counseling
- Arizona State School Counseling Certification
- Adheres to the American School Counselor Association Ethical Standards for School Counselors
- Fingerprint clearance

Preferred Requirements:

- Experience as a school counselor implementing the ASCA National Model
- Classroom experience teaching school counseling competencies
- One three years experience as a school counselor
- One three years experience as a teacher or knowledge and implementation of classroom management skills and lesson delivery
- Experience advocating for school counseling programs to all stakeholder groups
- Establishing professional relationships within the school and the school community to enhance student achievement
- Experience in the use of technology in research, school counseling program development, management, and delivery
- Actively involved in school community
- Leadership experience
- Participation and involvement in school counselor best-practice training at the local, state and/or national level
- Ability to work with diverse populations and cultures
- Continued professional development could include: ASCA National Model, Differentiated Instruction, Understanding by Design, Response To Intervention, Positive Behavior Intervention Support, and other state-wide initiatives
